APPLICATION RULES AND PAYMENT INFORMATION**

**Application Fee:** There is a **\$50 non-refundable** application fee for each participating vendor. Please include your check made out to Chilmark Church and signed application **by APRIL 1, 2026**

Please **do not drop off your application** at the Church; no hand delivered applications will be accepted. **Check or Money order ONLY**

**Payment for 2026 Season: All fees must be paid by CHECK in advance for dates reserved.**

Payments are due as follows:

June – July: Prior to June 27, 2026

Aug – Sept: Prior to August 1, 2026

The fee is \$60/show.

**As a reminder, no refunds will be given for missed shows.**

**Notification:** Vendors will be notified via email by the Chilmark Flea Committee on or before **April 15** whether their application has been accepted. Please note that we typically receive many more applications than the number of spaces on the field and the Chilmark Flea Committee will make vendor selections that are in the best interest of the Flea Market. The application fee will be refunded if Vendor is not accepted this season.

**Wait List:** We will maintain a wait list for vendors who have been approved by the Flea Market Committee but were unable to secure a space for the season. You will be contacted by the Vendor Manager if a space becomes available.

**Subletting:** We do NOT allow vendors to sublet their space. **Do not offer/rent your space to another vendor in your absence. We do NOT allow vendors to include wares from non-Flea Market vendors.**

**Vendor Wares and Behavior:** Wares and behavior of all vendors, their assistants/helpers and guests must be deemed suitable and acceptable by the Chilmark Community Church, the Chilmark Flea Market Committee and/or the Vendor Manager.

***NO Vendor can claim an EXCLUSIVE on the selling of MANUFACTURED items. Please include ALL wares that you are selling in your booth, Vendors may not sell items that are not listed on the 2026 application. Failure to do so can result in ejection from the Flea.***

## **2026 CHILMARK FLEA MARKET**

### **FIELD REGULATION**

1. **Payment: Please note All Vendors must pre-pay for reserved spaces.** Checks should be made payable to **Chilmark Church.**
2. **Absence from a booked Flea Date:** If you must be absent, please email (**NO Texts Please**) the Vendor Manager at least 48 hours in advance. Repeated absences without notification may result in loss of priority for the next season.
3. **Inclement Weather: *We cancel for stormy weather and all-day rain.***  
*WE DO NOT CANCEL FOR FOG, LIGHT MIST, OVERCAST OR CLOUDY SKIES.*  
*Vendor Manager and Flea Committee will decide by 6:15 a.m. and notify vendors by 6:30 a.m. via email if the flea will be canceled for the day, or delayed opening. If stormy conditions move in before 12 noon NECESSITATING CLOSING, all participants will receive a credit or refund.*
4. **Arrival and Setup:** Vendors may arrive between **7:10 and 8:30 AM** to set up. **No Early birds**, as the field is not managed until 7:10 a.m. Vendors who arrive past **8:45 AM will not be guaranteed a space.** **Vendors who arrive after 9:00 AM will not be allowed to enter the field.**

Once the Flea Market opens at 9am, no vehicle may enter or exit the field, except in case of emergency. **The Public is invited between 9:00 AM – 2:00 PM. All vendors must remain on the field until 2:00** You are responsible to bring tables or racks to display your goods. Large furniture, rugs and artifacts may be placed on the ground. **No items can be placed outside of the assigned 12 x 30 foot space.**

5. **Vendor Parking:** Vendors are allowed **1** vehicle **ONLY** per space and must be in the assigned space. There is **NO extra space for Vendor's "helper" and/or employee's vehicles.** Please make a plan with them so that they do not come to the field expecting to park there.
6. **Customer Parking:** The on-site parking is for **customers** coming to the Flea, and we ask vendors who invite visitors and **FRIENDS** to **limit their stay.** By doing so this enables us to offer free parking for our customers. Once the lot is full, we will initiate the **Lot Full** policy and put our sign out to indicate that **NO** more cars will be allowed into Flea. Less available parking equals less customers.
7. **Food Vendors:** Vendors serving food to the public **MUST** have a current BOH Certificate, Permit to operate, and ServSafe Certified. **FOOD** Vendors must supply a trash can accessible **to the public.**
8. **PLEASE DO NOT** put **YOUR** personal trash, boxes, packaging, etc. in the trash can by the bathrooms as this is meant for public use **ONLY.** Carry In, carry **OUT.**  
All vendors should pick up litter on or near your space before leaving.
9. **Flammable Materials:** No vendor or guest, shall use any fire/candles, etc. or flammable substance while at the Flea. Smoking is not allowed on the vendor field. Please ask visitors to put out and carry out smoking materials.
10. **Pets:** Vendors should **NOT** bring their pets to the Flea. Customers may do so only on a leash
